1)Information Collection and Use

In using our website, you will never be asked for personal information when viewing content.

If you choose to sign up for our newsletter, request research information or leave a comment, then you will be prompted for your email address and/or name.

A. Personally Identifiable Information: Collection

Personally identifiable information is data that can be used to contact or identify a single person. Through your own submissions, we collect your email if you want to subscribe to our newsletter, your name and email if you want to request research help and name if you want to comment on an article.

If you contribute content, we will include a link to your website or other site, as you instruct. We will list name, address, contact information only with your permission.

B. Personally Identifiable Information: Use

To provide you with the newsletter or research you request. To provide our readers with a way to reach those who contribute content.

C. Non-Personally Identifiable Information: Collection

Non-personally identifiable information includes general details about your computer and connection (including the type of computer/mobile device, operating system, web browser or other software, language preference, and hardware), the referring website, the date and time of visit, and internet content provider information.

D. Non-Personally Identifiable Information: Use

We may use your non-personally identifiable information and behavior gathered from transaction activity, our server log files, or from surveys to perform research on how to make the Services better for our Users and

Providers. The Company and its affiliates may share this aggregated data with business partners or other third parties to better understand our User and Providers, how the website is used, and how it can be made more effective for Users and Providers.

2)Protecting Personal Information

A. Important Disclosures

We reserve the right to disclose your personal information to protect our rights, comply with state or federal laws, judicial proceedings, or a court order. We also reserve the right to share information to investigate, prevent, or take action regarding suspected illegal activities, suspected fraud, situations involving potential threats to the physical safety of any person, violations of Terms of Use, or as otherwise required by law.

C. Do Not Track Signals

Some technologies, such as web browsers or mobile devices, provide a setting that when turned on sends a Do Not Track (DNT) signal when browsing a website or app. There is currently no common standard for responding to DNT Signals or even in the DNT signal itself. We do not currently have a mechanism in place to process DNT signals. However, we only track browsing history to determine the raw number of Users, without identifying specific Users, for the purpose of calculating the total number of Users who subscribe to a specific Provider and read specific Provider content.
