




Specs and Certs Update To Be Released Soon

On **Sunday**, **September 8th 2024**, Steelhead will be releasing an update to Specs and Certs.


The major change with this update is that Spec Measurements will now be associated to a Part Transfer Account, rather than a Work Order/Part Number combination, giving you the **ability to get more specific and the option to edit Specs.**

The following improvements to Specs will give you more flexibility and specificity:


- A new button will allow you to easily Split Spec Measurements and Reallocate to Parts. (Click Here for Step-by-Step Instructions)
- You will be able to resolve multiple failed Spec measurements with one Resolution Comment. (Click Here for Step-by-Step Instructions)
- The dialog box has been updated for the "COLLECT ADDITIONAL" button, allowing you to specify which Part Account the measurement is applied to. (Click Here for Step-by-Step Instructions)



The workflow for creating Certificates will allow for more customization and efficiency. These changes include:

- The ability to create and finalize a Cert in fewer clicks.
- The option to include and exclude Spec Measurements on Certs.
- A more efficient way to certify multiple Part Accounts at once, which will be a replacement for Master Certs.
- The ability to certify Partial Shipments.


New Courses in Steelhead University

Update to Contract Review for Spec-Related Recipes

With this update, you'll be able to correct order entry mistakes on Specs during Contract Review. It will allow you to go back and adjust the opt-in/opt-out settings and change selected Specs.

Product Update Highlights

Now View Sent Purchase Order Emails

Enabled users to view if an email has been sent for a Purchase Order. You may also email Purchase Orders from the Outsourcing screen.

Boolean Spec Measurements

Boolean Spec Measurements now have a Pass/Fail button instead of a checkbox.

Search for Parts with Empty/ Blank Location in Watch Tower

Now allows you to select a "No Location" checkbox to filter your search when searching for Parts.

Add Specs and Params to Work Order from Recipe Composer

This lets you resolve errors in Specs and Recipes at the same time when using spec-driven processing.
