Real Estate Information Management System (RIMS) Version 8.26.1 is a release for all RIMS 8 users.

These Release Notes provide a summary of selected bug fixes and performance improvements for the following noted areas:

### **QUALITY & USABILITY IMPROVEMENTS**

#### Award Amend Award

Issues were found related to user sending an amended award prior to the vendor accepting the award. The issue was corrected to hide the Amend Award button until the vendor has accepted the award.

#### Change Log Insufficient Date Task Status

The change log was logging a task status change of Closed when a task was cancelled by the system for insufficient data. Corrected the change log to reflect Cancelled rather than Closed.

#### Project Search Advanced Project Search

Advanced project search was not returning appropriate results when filter by internal task job manager. Updated project search to allow Job Manager and Vendor filter entries to be returned if found in any task on the job.

#### Reports Ad Hoc Reporting

Added new views for the following:

Customer was not able to add additional scope items. Increased the number of scope items to accept up to 32,767.

#### **Sampling Maintenance**

Clicking the Sampling Maintenance link returned an error when there was a very large set of sampling input rows to display. The issue was resolved by increasing the allowed number of records.

#### **SRF – FHA Case Number**

The FHA Case Number was getting cleared out when a new service was added against a new property or when a service request was cloned. The issue was resolved to correctly store the FHA Case Number. FHA Case Number is a project-level field and only allows one FHA Case Number per service request.

# Single Sign-On (SSO)

#### **Radio Buttons for Users with Multiple Accounts**

When a user had multiple accounts of the same user type, only one radio button was showing to select. The issue was resolved to show all accounts in all user types associated with the user logging in. The selection will now contain the name, login ID and email address in addition to the user type.

## Third-Party Services (*Updated* 10/13/2021)

#### **Third-party Integrated Services Transitioning to Unpaid**

If the RIMS site was configured to transition tasks to Unpaid, the third-party integrated tasks were not transitioning to Unpaid when the task was closed. The issue was resolved. For all third-party integrated tasks, where there is a fee, a vendor and the invoice is not fully paid and the task is not mapped to transition to Closed or Cancelled, the task will transition to Unpaid when the disposition is set.

#### **User Management**

#### **Import User ID Field**

Once entered, the Import User ID field would not allow the data to be cleared out. The issue was fixed so that the field could be edited to allow a NULL value.
